SUBMITTAL REQUIREMENTS

PROCEDURE FOR GROUND DISTURBING ACTIVITY IN ARCHEOLOGICAL ZONES, SITES, OR CONSERVATION AREAS:

NO CERTIFICATE TO DIG SHALL BE ISSUED FOR NEW CONSTRUCTION, EXCAVATION, TREE REMOVAL, OR ANY OTHER GROUND DISTURBING ACTIVITY UNTIL THE CITY'S STAFF HAS REVIEWED THE APPLICATION, EVALUATED THE SCOPE, AND DETERMINED WHETHER OR NOT THE MATTER SHOULD BE BROUGHT BEFORE THE HISTORIC AND ENVIRONMENTAL PRESERVATION BOARD (HEPB) FOR THEIR REVIEW.

REQUIREMENTS FOR STANDARD CTDs: (One complete set of the following checked items)

- PLANS:** NO LARGER THAN 11" X 17" PREFERRED WHEN THIS SIZE YIELDS SUFFICIENT DETAIL. PLANS MUST PROVIDE LEGENDS AND LABEL ALL INFORMATION.
- PHOTOGRAPHS: MUST BE PRINTED AT 4" 6" OR 2 PHOTOGRAPHS PRINTED ON 8.5" X 11"**
- ARCHEOLOGICAL SHOVEL TEST ASSESSMENT**
MUST INCLUDE THE FOLLOWING INFORMATION:
 - PHOTOGRAPH OF THE AREA TO BE IMPACTED
 - SITE PLAN SHOWING WHERE SHOVEL TESTS WERE PERFORMED
 - DESCRIPTION OF SHOVEL TEST
 - DESCRIPTION OF SITE CHARACTERISTICS
 - ARCHEOLOGIST'S CONCLUSIONS
- ARCHEOLOGICAL MONITORING REPORT DOCUMENTING NO CULTURAL REMAINS:**
MUST INCLUDE THE FOLLOWING INFORMATION:
 1. ADDRESS/LOCATION OF THE MONITORING
 2. A MAP FIGURE DEPICTING THE LOCATION OF THE MONITORING
 3. WHAT THE MONITORING WAS FOR (TYPE OF PROJECT)
 4. A BRIEF DESCRIPTION OF THE GROUND DISTURBING ACTIVITIES
 5. SAMPLE PHOTOS OF GROUND DISTURBING ACTIVITIES
 6. RESULTS; DISCUSS ANY RECOVERED OR OBSERVED CULTURAL MATERIALS OR FEATURES
 7. RECOMMENDATIONS FOR FUTURE MONITORING
